Dear Herget Families,


The staff of Herget Middle School is enthusiastic about the increased achievement of our students from last year to this year. We are fortunate to have dedicated families, teachers, and support staff who work hard to make Herget a successful school. While this year generally saw improvement in most subgroups and overall, Herget's Special Education (IEP) and Limited English Proficiency (LEP) student subgroups did not make adequate yearly progress (AYP) as defined by the guidelines of the Illinois State Board of Education on the mathematics test. Additionally, the LEP subgroup did not make AYP on the reading test.

As we evaluate individual student progress and group trend data, we assess and revise programs in order to meet the needs of our students and improve student achievement. During the 2009-2010 school year, Herget Middle School will:

- Implement School Board-approved changes to the middle school day to increase opportunities for student learning at the appropriate instructional level.
- Conduct regular, focused discussion with staff to assess individual student progress and group trend data to assess programmatic strengths and weaknesses;
- Conduct classroom walk-through visits and collect data to ensure that the staff is aligning lessons to the district's Priority Learning Targets and Illinois State Learning Standards;
- Provide opportunities for extended learning for students in the Enrichment and Talented program;
- Implement appropriate academic interventions to address needs of students not meeting expectations with the regular curriculum and instruction.
- Implement Positive Behavioral Intervention and Support (PBIS) across all grade levels to promote positive classroom climates and increase on-task, learning time;
- Continue to implement the Wilson Reading Foundation Reading Intervention Program and Read 180 for appropriate special and regular education students;
- Continue to provide special education services in the general education classroom setting when appropriate, which meets the requirements for least restrictive environments;
- Offer after-school academic and social support for students at risk of academic failure—specifically those not meeting state standards as measured by ISAT—by partnering with the Communities in Schools "My Time" program;

We invite all parents and members of the school community to join us in our mission to make Herget Middle School a great place to learn!

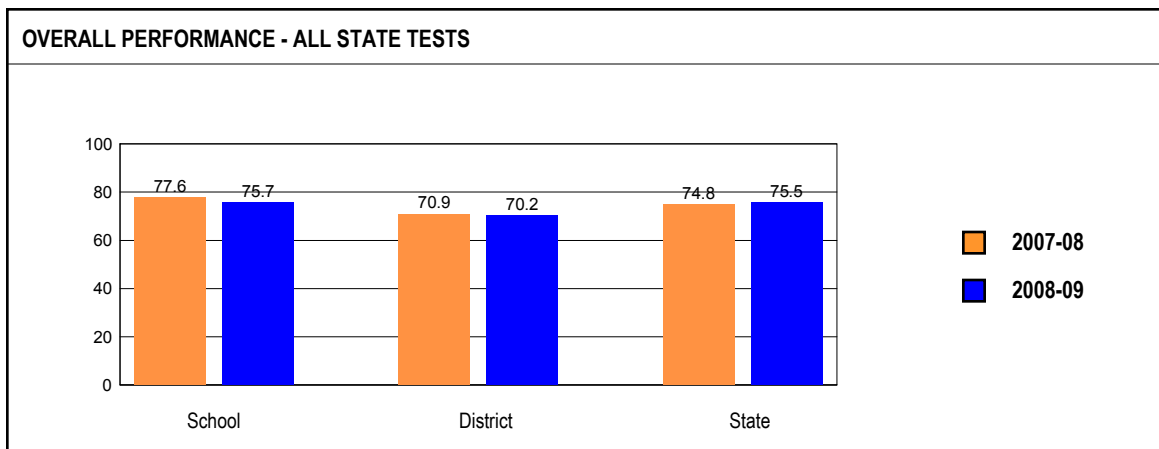

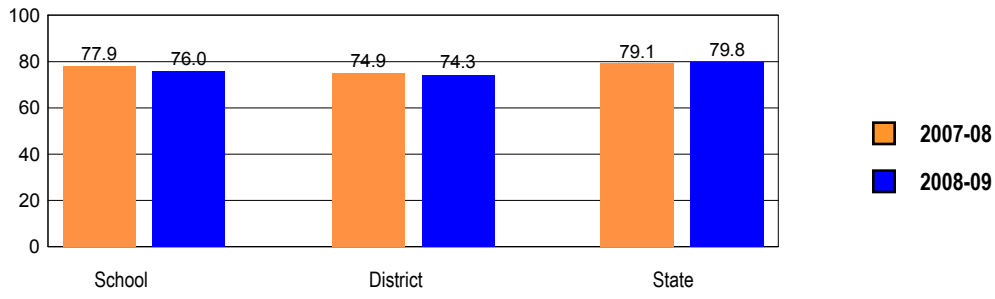
### OVERALL STUDENT PERFORMANCE

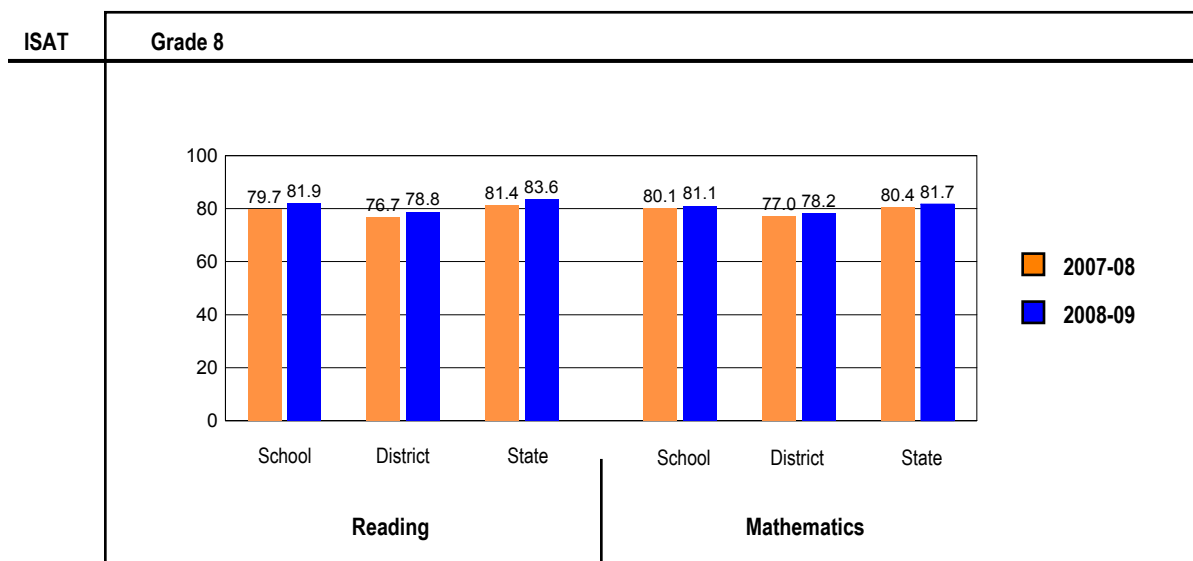
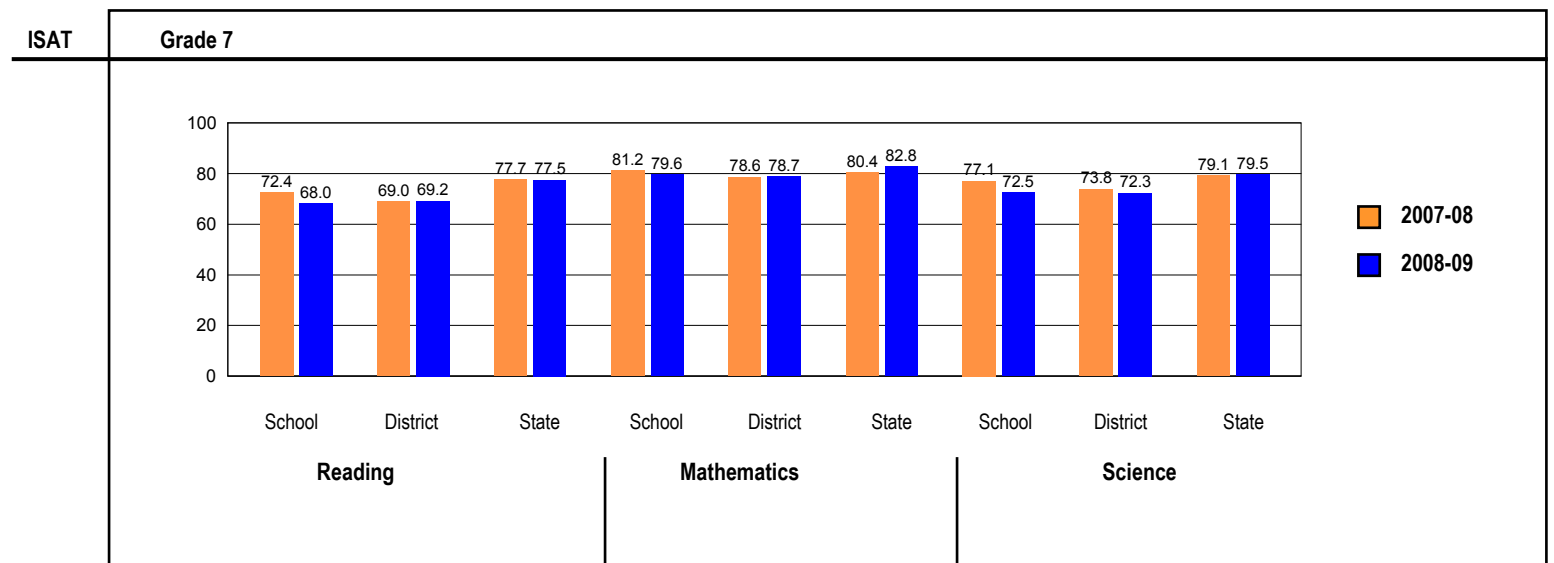
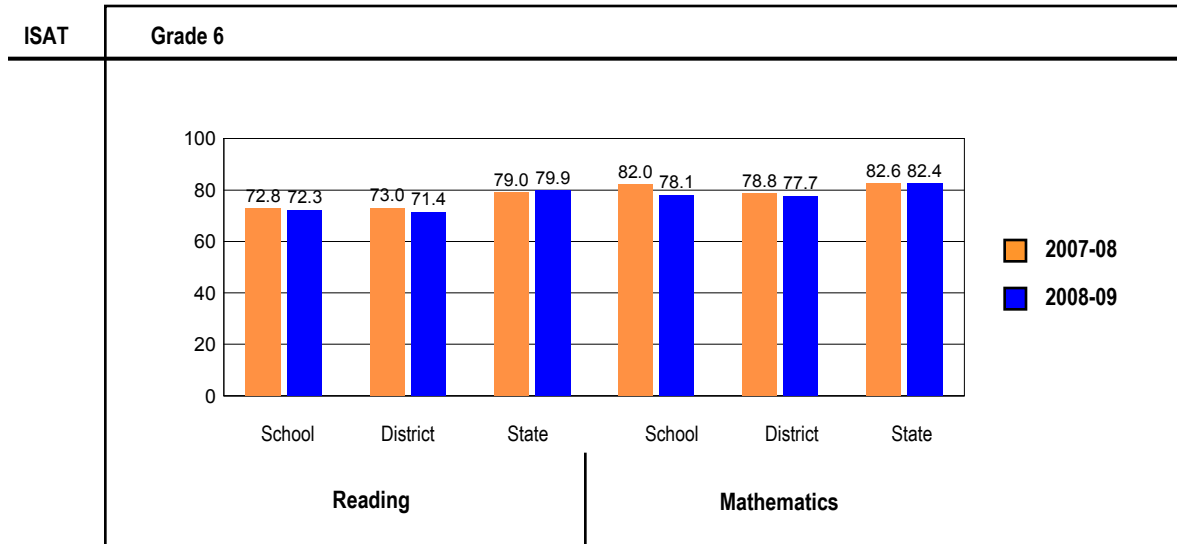


**OVERALL ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT) PERFORMANCE**



**ISAT PERFORMANCE**

## PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics, and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

Reading and Mathematics are tested in grades 3 through 8 and 11. Science is tested in grades 4, 7, and 11.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

**ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT)**

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.

Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.

Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.

Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.
