Dear Jefferson Families,

The staff at Jefferson Middle School works hard to achieve the Adequate Yearly Progress standards set by the state. Our scores have remained fairly steady with our overall population achieving AYP in reading and math. However, we have three subgroups that did not make AYP in reading and math. They are Limited English Proficiency (LEP), Special Education (IEP) and low-income students in reading.

Our staff at Jefferson will work diligently to improve our scores and provide a quality education for all students. This is a work in progress and we will continue to evaluate our data and be flexible in our planning. As we look at what has been successful, there are particular programs and strategies that will continue and others that will be implemented at a later date. Some of these include:

- Implementation of School Board approved changes that provide additional language arts and reading instruction.
- Partnership with North Central College to provide tutoring assistance for our LEP students. Aurora University is also providing tutoring for struggling readers.
- Continuation of PBIS. Positive Behavioral Interventions and Supports is a school-wide initiative to improve student behavior. We feel PBIS will lead to increased academic achievement and a sense of community within the building.
- Continuation of Read 180 and Wilson reading programs for our qualifying IEP students.
- Continuation of the My Time after-school program, which provides academic support for students as well as alternative activities during the after-school hours.
- Continuation of dialogue among staff to improve instructional techniques.

We will continue our efforts to improve academic standards for all students. Our mission is to provide a safe learning environment where all students are challenged and achieve their potential.

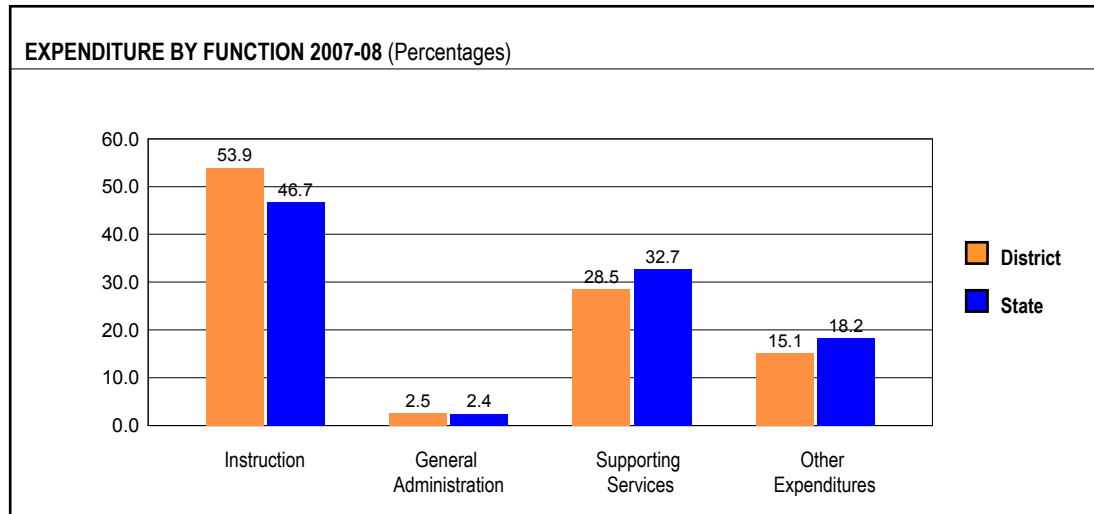

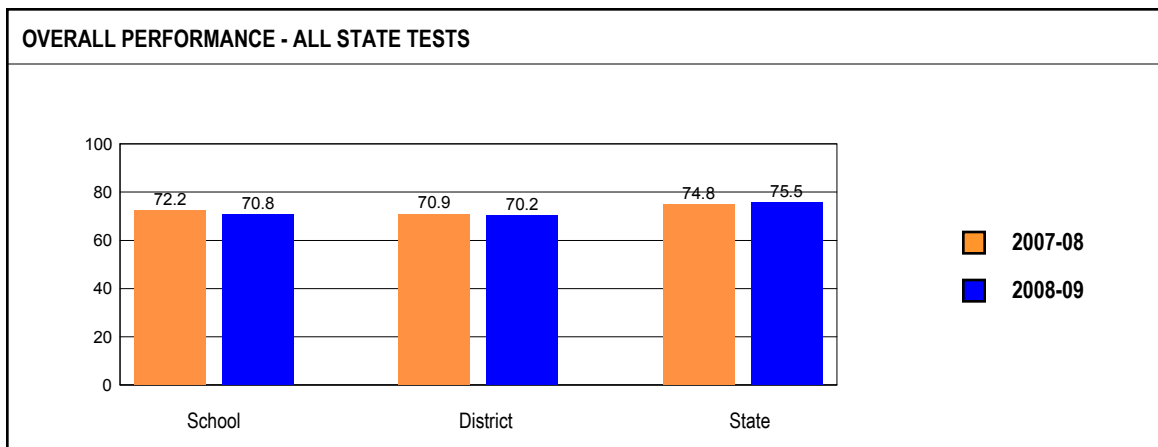

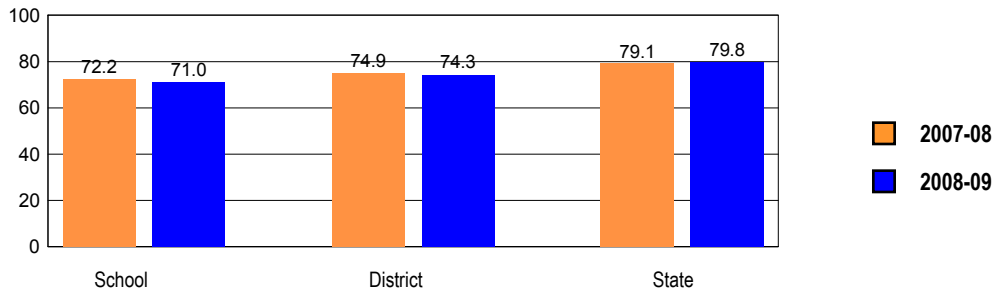
OVERALL STUDENT PERFORMANCE

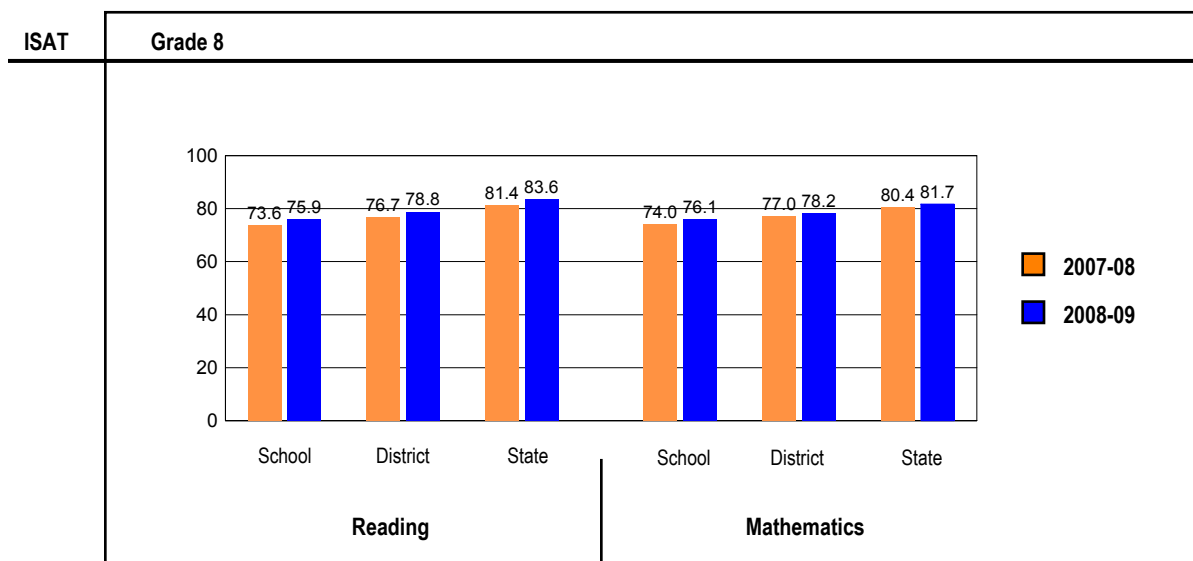
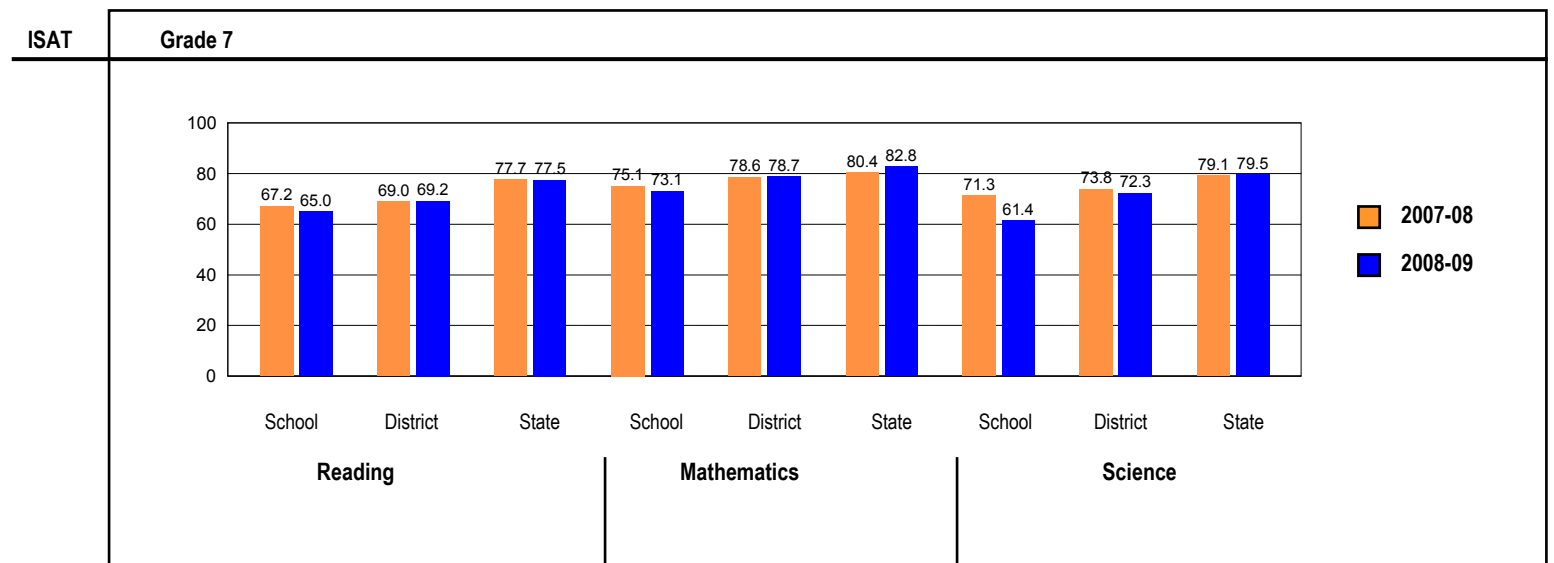
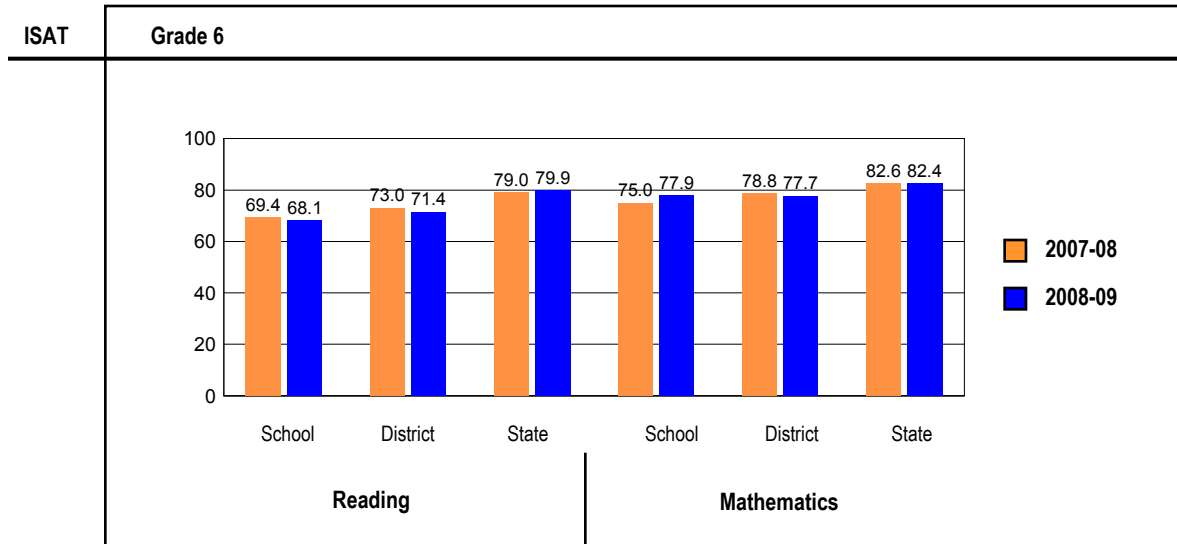


OVERALL ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT) PERFORMANCE

PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics, and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

Reading and Mathematics are tested in grades 3 through 8 and 11. Science is tested in grades 4, 7, and 11.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT)

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.

Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.

Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.

Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.
